Overview

To claim the federal solar tax credit, you will need to file an IRS Form 5695 for the tax year which your project “expenditure” was made. With regards to the tax code, your expenditure is considered complete when your system is installed —not necessarily when you sign a contract to. The Residential Clean Energy Credit equals 30% of the costs of new, qualified clean energy property for your home installed anytime from 2022 through Decem. According to a 2023 industry report, over 20% of eligible homeowners miss out on this valuable credit or file for it. Use these steps for claiming a residential clean energy tax credits. According to EnergySage, an alternative energy marketplace, it costs about \$28,000 to install a typical system.

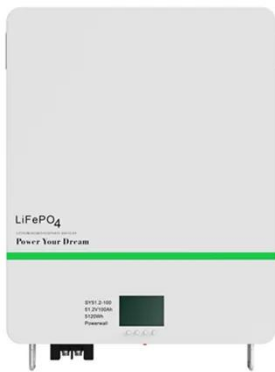

not merely purchased.
