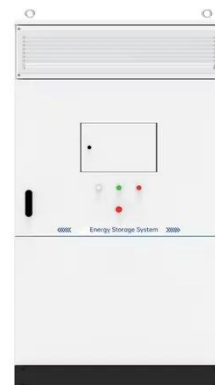


What Are the Specific Accounting Considerations for Capitalizing ...
