Unless the underlying jurisdiction does not require any zoning at all, most cell towers must be approved by the local land use office prior to being built. 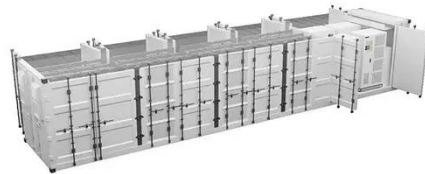

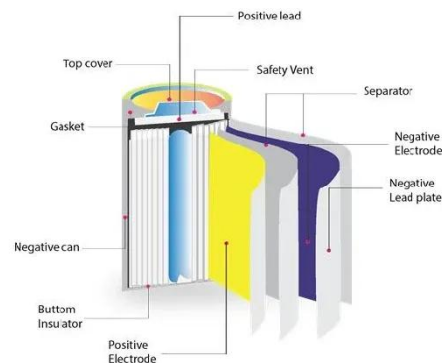
