Overview

The European Commission has approved, under EU State aid rules a €17.7 billion Italian scheme to support the construction and operation of a centralised electricity storage system. The measure contributes to the achievement of the objectives of the European Green Deal and 'Fit for 55' package, by. Zelestra Italy develops photovoltaic, agrivoltaic, and battery energy storage (BESS) projects across six Italian regions, spanning the islands, southern, and central-northern areas, with a total pipeline exceeding 1. Just under 4GWh is completed and/or operational, with a further 2GWh+ under construction. The demand for energy storage in Italy has been clear over the last half a decade, with solar and wind generation. The Italian government has authorized eight BESS projects that will strengthen the stability of the power grid. Companies such as Edison Next and GreenGo stand out in this initiative.
