Overview

This guide explains how UL and ASTM standards, as well as FCC Part 15 and other requirements, apply to solar panels sold in the United States. The safe and reliable installation of photovoltaic (PV) solar energy systems and their integration with the nation's electric grid requires timely development of the foundational codes and standards governing solar deployment. The California RPS program was established in 2002 by Senate Bill (SB) 1078 (Sher, 2002) with the initial requirement that 20% of Solar, or photovoltaic (PV) panels as they're referred to in NFPA 1, Fire Code, are becoming more and more common on one- and two-family dwelling and townhouse roofs. Since the 2016 edition of NFPA 1, access pathways have been required on roofs to facilitate fire service access as well as egress. There is a patchwork of federal, state, and local policies and regulations pertaining to renewable energy systems that impact your project development.
