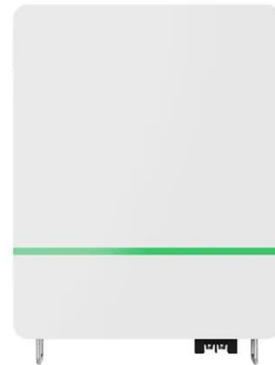

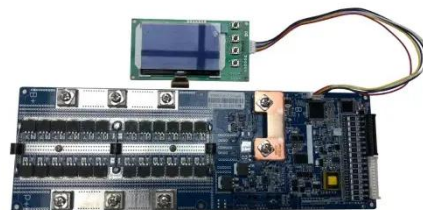


Coast Guard Accepts ABYC Navigation Light Standard

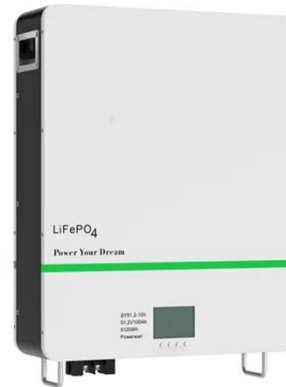
