Mark Leroy Dencklau and Chad Leroy Erickson were found guilty of murdering Robert Huggins and dumping his body in a field near Ridgefield in Clark County. 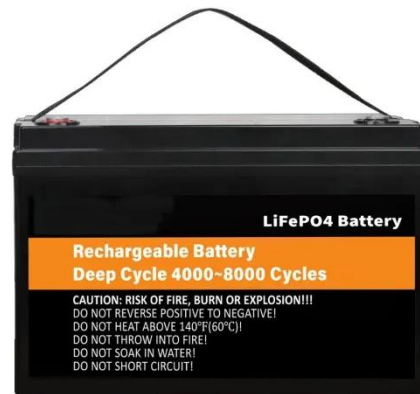

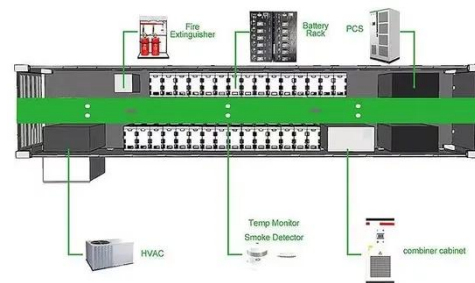
